1. Scope

These terms and conditions apply to all works, benefits and services that the Swiss Consulting Group SCG Ltd, Orpund / Biel (hereinafter: provider) or without payment provides with respect to the Swiss Create Business Manager software developed by it against users. Conflicting terms and conditions do not apply, unless the provider agrees to these in writing agree.

3. Use / prices

The Internet use by Swiss Create Business Manager is principally permitted to everyone. The providers differs in the use of Swiss Create Business Manager between unpaid and paid use. Free is the use of Swiss Create Business Manager for testing purposes or as invited guest of a paying user.

The full version of Swiss Create Business Manager can be used only after prior usage contract. The use of the full version is not included. Swiss Create Business Manager provides the registered users in not specified intervals updates for the duration of each registration period available.

Contractor having overall responsibility for the Swiss Software Create Business Manager which of its acts and compliance with these Terms and Conditions by all members of the respective user who has to log in to use the start by means of the registration form. By sending the registration, the contract comes into existence.

The prices are net. Decisive are the prices of the current price list. Other goods and services, for the time of your order no price has been agreed shall be charged at the list prices valid on the day of delivery. Change of fees remains reserved.

4. manner of use

The setting and spread of any material that violates laws, especially criminal law, violates and posting messages or other material that violates laws of the recipient country, is prohibited. The assertion of claims for damages in such cases is reserved.

All clients are obliged to respect the copyright of the supplier to secure, within their use and reproduce any of the providers made available, proprietary information, software or other content that transmit or otherwise distribute.

The user agrees to the suppliers of all claims for damages to indemnify, which are levied by third parties due to damage from a client in connection with the use of Swiss Create

Business Manager against the provider.

5. Availability / warranty

The provider operates Swiss Create Business Manager with due diligence and reliability. He strives for the constant availability of Swiss Create Business Manager and announces necessary interruptions to the extent possible. The user acknowledges, however, that, for example, already for technical reasons and because of the dependence on outside influences within the framework of telecommunications networks uninterrupted availability of Swiss Create Business Manager is not possible. It can also lead to unannounced interruptions under certain circumstances. Only temporary access restrictions not grant warranty claims nor a right to exceptional termination. A few weeks before ending of the contract he will get a reminder to extend his license if he wants to use all functions of Swiss Create Business Manager furthermore.

Fulfillment is Orpund / Biel. It is only the Swiss law.
